

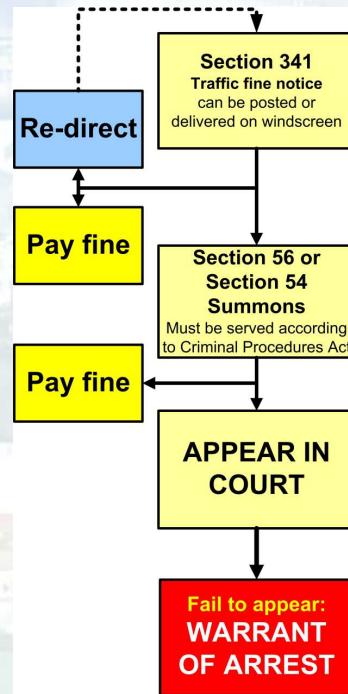
Traffic fine? Arrest for Contempt of Court?

- In light of the ongoing confusion around motorist's rights at a roadblock, here are suggested guidelines if an attempt is made to arrest you at a roadblock.

- A copy of the Warrant of Arrest must be supplied on demand by the arresting officer .
- A copy of the Warrant does not need to be available immediately, but you cannot be detained while the Warrant or a copy thereof is being fetched from a police station some distance away.
- You have the right to be informed of your constitutional rights which include the reasons for your arrest and detention.
- If you are subjected to any abuse of your human rights, you will have a claim against the authorities.
- After your arrest you must be brought to the place stipulated in the Warrant or a Police station (SAPS) as soon as possible after the arrest was made.
- Please note that the arrest has not taken place because of failure to pay a traffic violation but because you failed to appear in Court pursuant to a Summons.
- You have no right to see the return of service at the time of your arrest. This can be obtained later. Please note that the Magistrate has seen the return of service and issued the Warrant for your arrest on the basis of the information contained therein.
- In all circumstances where you are unsure about the procedures followed, keep notes and records of time, places and specifically the names of the officials involved.
- The most important advice is to ensure that you act immediately when you receive a traffic fine and, when you make payment, ensure that you do receive a receipt or keep proof of payment if the payment was made electronically.

Notice to fleet owners and company proxies

In terms of the Law the licensed owner of a vehicle, and in the case of a company- the company's proxy, is deemed to be the offender / driver of the vehicle unless the traffic fine can be successfully re-directed.

It is therefore recommended that you keep accurate records of the drivers of your vehicles.

General traffic information

HOW TO REDIRECT/RE-ISSUE A FINE?

A traffic fine can only be re-directed on the first notice received. An Affidavit must be completed with the following information regarding the driver of the vehicle at the time the offense was committed and it must be signed and stamped by a Commissioner of Oaths:

- Full names and surnames
- ID number or passport number
- Full physical / residential address
- Full Postal address

General information on Registering & licensing issues

- You are obliged to notify the Registering and Licensing Authority of any change of address within 21 days of such a change (NCP)
- You are obliged to notify the Registering and Licensing Authority within 7 days should you vehicle be stolen (Affidavit).
- If you sell or trade in your vehicle or hand it to an insurance company after it has been written off or if a vehicle is scrapped, you have to notify the registering and Licensing Authority of such event within 21 days (ADV).
- Should the owner of a vehicle fail to comply with legislation (change of ownership) he/she will remain liable for all outstanding traffic fines and a fine may also be imposed for failure to submit the documentation in time to the relevant Registering & Licensing Authority.
- All the relevant documentation is available on the www.enatis.co.za website. It is recommended that the owner of a vehicle ensures personally that transactions are processed by the Registering & Licensing Authority.
- If your vehicle is registered within the boundaries of the city of Johannesburg, you may renew your annual vehicle license with anyone of the following departments listed below.
